* Forestry residues must be by-product of preventative treatment for reduction of hazardous fuels or reduction or containment of disease and insect infestations and would not be otherwise used for higher-value products.

Who can be an eligible material owner?

A person or entity (e.g. landowner or operator) having the right to collect/harvest eligible material and who has risk of loss in the materials delivered to a qualified biomass conversion facility, under an approved BCAP contract.

What is eligible material?

Eligible material is renewable biomass but excludes material that is a whole grain from any crop that is eligible to receive payments under Title I, "Commodity Programs" of the 2014 Farm Bill, animal waste and by-products of animal waste including fats, oils, grease & manure, food & yard waste, algae and bagasse.

What are the payment limits?

There are no payment limits; however, an eligible material owner may only receive payments for a period of two years.
